2022 City Commission Priorities

The City Commission Priorities reflects the 10 highest priorities of the Board of Commissioners for calendar year 2022. A quarterly update on the 10 priority action items and continuous improvement items was provided to the Board of Commissioners in mid-April, July and October. This is the annual report for the Commission Priorities. A communications plan was implemented for each priority action item. Finally, the Board of Commissioners and City Manager's Office were involved in each priority item.

2022 City Commission Continuous Improvements

The Board of Commissioners recognizes there are 2021 priorities needing continued focus. The three areas with updates are below.

Stormwater

- The City allocated \$4 million in ARPA funds for stormwater projects highlighted below:
 - The Buckner Lane Bridge Replacement Project is 95% complete and will be finalized in the early spring. The project completion date was January 11, 2023. Since, the contractor was unable to continue work in late December because of severe weather conditions and asphalt plants being closed, the project was shut down for the winter on December 22nd. The final top layer of asphalt and the final landscaping will be performed when the asphalt plants reopen and the weather allows.
 - The South 25th Street improvement project is 75% complete, and we have experienced significant construction challenges. The project was shut down on December 24th for the winter. It is anticipated that the work will resume and be completed in the spring as weather allows the work to resume. The project includes work on South 25th Street from Jackson Street to Alabama Street as well as improvements in connectivity, walkability and drainage.
 - In addition, the Engineering Dept, using City budget funding & existing annual contracts, was able to make a much-needed drainage ditch improvement stretching approximately 1550' along Central Avenue. This project has been consistently monitored for its performance. Based on the monitoring, we are pleased with the improvement as it has provided for a safer pedestrian and vehicular pathway for citizens in this area.

City Facilities

- The City allocated a total of \$800,000 from the Investment Fund to initiate the City Facility Improvement Trust Fund in FY22 and an additional \$300,000 in FY23, achieving the goal of having \$1.1 million available for use in FY23 to begin facilities maintenance projects.
- The facilities projects from the 2020 facilities study are prioritized and work has been focused on City Hall basement and sewer, Fire Station 2 exterior improvements, Fire
 Station 4 apron & sewer improvements and Fire Station 5 flooring. Upcoming facilities projects being considered include the Allie Morgan building and the Recreation Center.
 The Facility Improvement Trust policy is also currently under review for the FY24 budget.

• Joint City/County Sportsplex

- The City, County and Sports Commission signed the Interlocal Agreement on September 7th. The Sports Tourism Commission has executed contracts with PFGW, BFW, and SFC (Sports Facilities Companies) for the schematic design, environmental testing, and programmatic design.
- o Design Team has representation from City, County, and Sports Tourism Commission and is meeting weekly to refine schematic design.
- o Work Group established earlier this year to include County, City, and Sports Tourism representation working directly with the operator on programmatic design.
- Stakeholder meetings were conducted on November 29 and 30 at the Convention Center in downtown Paducah. Representation from Design Team, SFC, Parks, County, and Sports Commissioner met with various stakeholders to discuss needs, wants, and concerns for the project to include both school districts, youth soccer, baseball, softball, cross country, disc golf, dog park users, pickleball, NAACP, and other.
- County has acquired 2 additional properties located on Metcalf Lane through purchase contracts with current property owners. Metcalf Lane is being included as part of the schematic design with considerations to include maintenance and back of house type entry into the facility
- Stuart Nelson Park is tentatively scheduled for closure to the public in 2023 to accommodate construction. Currently, Parks and Recreation has stopped taking reservations for August – December and are asking those callers to check back in with us in a few months for an updated timeline.
